Submission Policy

2. We require all articles/letters to signed by the writer and to include his/her title, if representing an organization. This should be in the upper right hand corner of the first page.

3. We require all articles/letters to be neatly written or typed and doublespaced on a 55 space line.

4. We require all writers to count the number of words in the article/letter and place it on the first page.


5. We reserve the right not to print material that:
