

In an interview with Andy McNally, the new Civil Preparedness Director, he made it quite plain that all Pine Knoll Shores residents should know their area Civil Preparedness co-ordinators.

In the event of a hurricane or other townwide emergency, your Area co-ordinator is authorized to communicate with all residents in his area concerning hurricane warning evacuation etc. He will be working through neighborhood block captains. We need volunteers for this work - it takes very little effort but is vital in times of emergency. The main task is official communication from area co-ordinators to a given group of neighbors concerning impending emergencies.

All residences on Salter Path Road east of Mimosa Blvd. and west of Reefstone and Coral Bay West. All residences on Maple Court, Pinewood Drive and Knollwood Drive.

Area 2 - Co-ordinator - Al Wylie - 726-1313

All residences on Magnolia Court, Elm Court, Cypress Court, Cedar Road, Holly Road, Yaupon Road, Willow Road, Juniper Road, Cypress Dr. and Oakleaf Dr. east of McNeil Inlet.

All residences on Salter Path Road west of Mimosa Blvd. and east of Pine Knoll Blvd. (Bridge Rd.) (exclusive of condominiums), Arborvitae Dr., Dogwood Circle, Ramsey Dr., Arborvitae Court, Cottonwood Court, Chestnut Court, and Hemlock Court.

Resident managers of all condominiums and motels will be notified of emergency conditions and evacuation advisories by the Pine Knoll Shores Police Department.
