The Planning Board met on July 15. In reviewing the previous meeting it was pointed out that consideration of changing the minimum "lot" size to 1200 square feet was meant to be "house" size. The Board of Commissioners is not requesting any action from the Planning Board on this point at the present time.

There was more discussion of the sign ordinance concerning commercial zones which is being prepared for presentation to the commissioners.

Robert Youngblood, as requested, presented his plans to fill in lots 1, 2 and 3 of the Fairway Subdivision and a storm water management plan approved by an engineering firm. The Board members tabled the proposal with the understanding that the Building Inspector would look it over and give a report on it.

Clyde Lynn gave a report on the Litter Ordinance. The area where most violations occur is around the Iron Steamer Pier. Management seems to be unable to contain the problem.

Harry Schlimper gave an account of his meeting with the State Department of Transportation in regard to the drainage from the highway into the canal and the pollution it causes. A 5-inch collar could be placed on the drain pipes so that no water would drain into the canal unless there was a deluge which raised the water above that level in the road gutters. He added that the town is also making a study of what effect heat pump drainage into the canal has on pollution.
