

### TOWN HALL MEETING SCHEDULE

### CHRISTMAS PARADE

To Ramsey Drive, right on Arborvitae to Salter Path Rd., left to Oakleaf, then to Juniper, right on Cypress, to Cedar and back to Oakleaf; from Oakleaf to Mimosa and right on Loblolly and back to Mimosa, then left on Beechwood and left on Sycamore to Hawthorne; left on Hawthorne and back to Mimosa to Salter Path Rd. and back to Town Hall. Rain date is December 17.

### INSPECTIONS AND PLANNING

During the month of October, 1994, the PKS Inspections Dept. issued four residential permits for a construction value of \$1,562,000. One of the permits was for the new "Pine Knoll Shores Condominiums". It's a luxury six unit condo over 18,000 sq.ft. under construction west of Genesis and east of The Oceans condos off Salter Path Road on the ocean front. There were 13 miscellaneous permits issued for a construction value of \$141,400.

PKS has limited potential for additional growth. Most of the town, approximately 60%, is zoned for residential development. Nearly 260 acres of land remain for both single-family and multi-family development. Of that total, approximately 16 acres remain available for multi-family development. At current densities, roughly 565 additional residential units may be constructed.
