(A verbal commitment is not sufficient!) This is especially true with tree removal permits! Your cooperation in this regard will prevent a lot of disgruntled neighbors and significantly reduce unnecessary telephone calls. Thanks!



The health topic this month concerns <u>Spotting</u> Health Fraud.

Americans waste billions annually on bogus treatments that promise to be a simple solution to better health.

To recognize a worthless treatment, ask:

- 1. Does it promise too much too easily? Unproven remedies are often promoted as cure-alls, from preventing aging to curing impotence.
- 2. Does it claim immediate or guaranteed results? Few medical treatments produce immediate benefits for chronic conditions. And even proven therapies can't always guarantee better health.
- 3. Does it include a secret or exclusive formula? Legitimate therapies evolve from data collected and reviewed by many scientists.
- 4. Are testimonials the only proof it works? Unproved remedies are typically endorsed by "satisfied customers." These people may be paid for their comments or lulled by the power of suggestion into the belief they were "cured."
- Does it offer a money-back guarantee? A guarantee is an effective ploy to get you to buy. But don't expect a response to a refund request.

If you question a medical treatment, discuss it with your doctor or another health care professional, or write to the National Council Against Health Fraud, P.O. Box 1276, Loma Linda, California 92354.
