

Free Chest X-Rays To Be Given At Mills

ounty-Wide New Registration Under Way

Fieldcrest people are reminded of the complete new registration ordered by the Rockingham County Board of Elections for all 30 precincts in the county. No citizen of Rockingham County will be eligible to vote in the general election on November 4 or in future primary or general elections unless he or she re-registers.

The registration books were open on the registration books were open the Sa'urdays, October 11 and 18, at the polling places throughout the county. The registrars will again be at the voting places on Saturday, October 25, from 9 a. m. until sundown. This will be the last day for re-registering before the November general election.

It was emphasized that only those persons who have registered anew will be eligible to vote in the November 4 election. It was stressed also that the registration is county-wide and is not to be confused with the recent "pre-

cinct splitting" in Leaksville Township. Notices have been posted in the mills

calling the attention of employees to the new registration. Accompanying the notices are maps showing the boundaries of the various precincts in Leaksville Township where new precincts were recently created.

Persons On All Shifts To Have Opportunity To Obtain X-Rays

Every employee in the North Carolina mills will have an opportunity to obtain a free chest x-ray when the mobile x-ray unit of the N. C. State Board of Health visits the mills. The program is part of a mass chest x-ray survey being held throughout Rockingham county.

As in the past, employees will be released from work long enough to have an x-ray made. The schedule is arranged so that employees on all three shifts will be able to get chest x-rays.

A chest x-ray survey is an effective method of finding tuberculosis and other chest conditions, such as some types of heart disease. Early diagnosis of other chest conditions leads to earlier treatment and recovery at less expense and lengthens life.

The work in the North Carolina area is being sponsored by the Rockingham County Commissioners, the Health De-
