Exemption Changes Should Be Reported

Employees who have had changes in the number of exemptions claimed for federal income tax deductions should notify the Payroll Department right away. The change in status should be reported on form W-4, which may be obtained from the foreman, timekeeper, or the Industrial Relations Dept.

All changes received by the Payroll Department by January 31 will be put into effect. There will then be no further exemption changes on the payroll until July 1. However, employees should continue to notify the Payroll Department within 10 days of any change in their dependents, such as divorce, separation, births, dependents earning over \$600, etc.

Any overpayment or underpayment of tax by an employee will always be adjusted by the U.S. Department of Revenue when the employee files his income tax for the year.
