## Newsweek' Editor To Speak Tuesday

Hal Bruno, news editor of Newsweek magazine, and chief of its New York bureau, will be the featured speaker at the closing "Great Decisions" forum to be held at 8:00 p. m. Tuesday, April 4, at the Morehead High Auditorium.

The prominent newsman will speak on "How Asia and Africa Look at Red China." Following his speech there will be a question-and-answer session.

As a newspaper reporter and magazine correspondent, Bruno has covered assignments that have taken him to far <sup>corners</sup> of the world—from Chicago's police beat to remote regions of India and the Middle East.

In 1956 he was granted a leave of absence from the staff of The Chicago American to accept a Fullbright scholarship to India where he conducted a study of the news problems and working conditions of the Indian press.

Bruno wrote a prize-winning series of articles from Israel for The Chicago American; and worked with the International Press Institute in Zuricn, Switzerland, on a series of reports about Problems facing the press in underdeveloped nations. In the summer of 1958 he was sent back overseas to cover the Middle Eastern crisis. He landed in Lebanon with the airborne troops, covering the rebellion there, the tensions of Jordan, and flying with carrier-based

## **Deadline Nearing For Filing Tax Returns**

Have you prepared your federal income tax return yet? If not, the time is getting close. And returns prepared in haste are more likely to have errors in them. You can save the Internal Revenue Service and yourself valuable time and money by carefully checking your tax return before you mail it.

The following check list will be help-ful:

- 1. Check arithmetic.
- 2. Attach Forms W-2 from all employers.
- 3. Sign your return. Both husband and wife must sign a joint return.
- 4. Print or type name and address, including zip code.
- 5. Use correct tax table.
- 6. Total your deductions if you itemize them on page 2.
- 7. List your Social Security number correctly. Both husband's and wife's number should be reported on the joint return.

Remember that for income tax purposes a wife is never a dependent of her husband. The exemption allowed her is based upon the marital relationship, not on dependency. A husband may claim his wife's exemption on his separate return only if she has no income and is not the dependent of another taxpayer. Husbands and wives may file joint returns even though one of them has no income.

If the wife had income in any amount, the husband can claim his wife's exemption only by filing a joint return with her. On a joint return, income and deductions of both husband and wife must be included, and both must sign the return.

Do you have a refund due on your federal income tax return? By mailing it to the correct address, it will help speed the processing and refunding procedures involved by eliminating one handling operation.

North Carolina taxpayers should mail returns showing refunds directly to the Southeast Service Center at Chamblee, Georgia. The address is 4800 Buford Highway, Zip Code 30006.

A preaddressed envelope for this purpose is included with your tax form package. If it was mislaid or lost, a new (Continued on Page Eight)
