Know Your Benefits

Q. How long does Fieldcrest group insurance cover my children?

A. Children are entitled to dependent benefits from birth. After 14 days from birth, they are covered by all benefits, including Dependent Life Insurance, until age 19. Unmarried children who are full-time students are eligible for benefits until the last day of the month in which they become 23 years of age.

Q. My husband and I both work at Fieldcrest. Does his Family Plan group insurance cover me and our children?

A. No, it does not cover you. While your husband's insurance covers him and the dependent children, you are not included because a person working at Fieldcrest and eligible for the insurance is not considered a dependent. You would need to take the single coverage in order to have insurance your-
