Bill Introduced To Pay Explosion Claims

The following bill was introduced in the Senate of the United States by Senator J. W. Bailey on October 13,

The bill was read twice and referred to the Committee on Claims.

A BILL

For the relief of certain claimants against the United States who suffered personal injuries, property damage, or other loss as a result of the explosion of a munitions truck between Smithfield and Selma, North Carolina, on March 7, 1942.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled.

That the Secretary of the Treasury is authorized and directed to pay, out of any money in the Treasury not otherwise appropriated, to the claimants hereinafter named, the sums hereinafter specified, in full satisfaction of their respective claims against the United States for compensation for property losses or damages sustained by them as the result of an explosion which occurred when a truck in which munitions were being transported for use by the United States Army collided with a privately owned passenger automobile at the intersection of United States Highways Numbered 301 and 70, between Selma and Smithfield, on March 7.
