

## **Trees Must Live if ASC Is To Share in Planting Cost**

disappointment when they start to collect for trees planted under ACP and Sold Bank Conservation Reserve contracts.

The contracts state that a satisfactory number of the trees must be living at the end of the first summer. In addition, Soil Bank tree planting contracts require that a satisfactory stand of trees must be maintained on the land during the term of the contract.


Inspectors for the North Carolina Forest Service say that a great many areas planted in trees this year are already failures and definitely will not qualify for government cost-sharing.


The foresters say that failures are caused by : (1) Improper care of seedlings before planting, and (2) poor planting procedures.

Fred Claridge, state forester who is responsible for inspection of these tree plantings, says that each planting will be carefully checked. Those plantings not meeting survival requirements will be turned down for payment if the plant-
