Hinson described the play, and the sports writer jotted down the information. In fact, he even went so far as to write an advance story about the game's outcome, and stuck it in his desk.

The game turned out to be bitter battle that everyone had predicted. Neither team could score. With less than a minute to play, Appalachian was on its own goal line, and fourth down was coming up.

Hinson dropped back into the end zone, in punt formation. He faked the kick, and started run-
