# High Dam Construction Begins in December.



Construction of the Aswan High Dam, which will be built in two stages over a period of ten years, will get underway in December following the recent approval by the United Arab Republic of final plans proposed by Soviet experts. The Soviet Union contracted to build the first stage in an agreement signed on December 27, 1958.

In order to expedite construction, and bring in heavy equipment, the UAR built a road to the site, an airport, and extended railways to Aswan. Currently, the Government is constructing an entire housing unit for workers and experts.

A major project in President Nasser's economic development program, the High Dam will increase the Egyptian Region's cultivated area by 1,300,000 acres. The new dam will hold 130 billion cubic meters of water-25 times the capacity of the present Aswan Dam.

bine the newly purchased land with what he already owns, he must file a request with the county committee for the combination.

The county committee, according to Ratcliff, may not approve a combination unless the tracts are operated in the manner prescribed by the Secretary's regulations and instructions. Before approving a combination for additional land purchased, ASC committees are also required to determine that a legal deed has been made

Ratcliff further urged that lawyers or real estate agencies who are handling the sale or purchase of farmland or who are advising farmers in such transactions become familiar with the regulations before advising their clients or completing any transaction.
