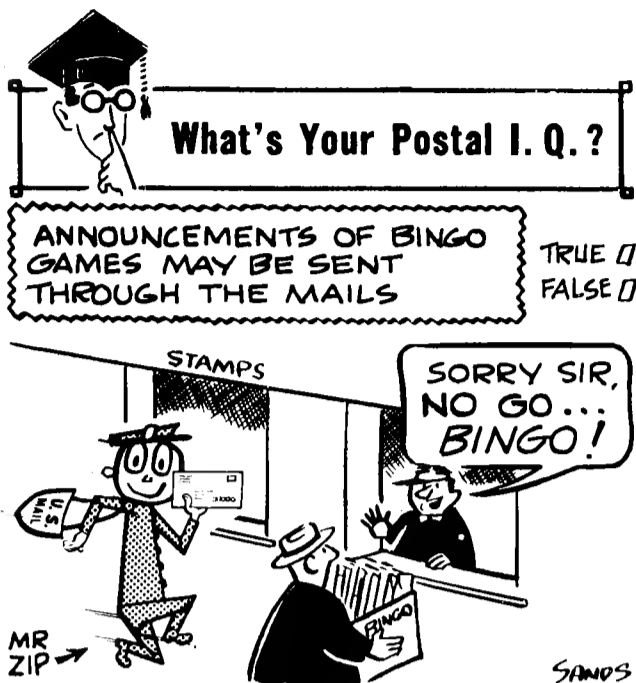

TO WHOM IT MAY CONCERN: to the parties above named and all other parties interested will take notice that on 1st day of October 1963 the above named petitioner filed a petition in the Office of the Clerk of the Superior Court of Pamlico County to have the title to certain lands therein described registered and confirmed pursuant to the provisions of Chapter 90 of the Public Laws of 1943 and acts amendatory thereof and supplemental thereto (Chapter 43 of the General Statutes of North Carolina) and that summons has been issued returnable at the office of the Clerk of Superior Court, Pamlico County on the 1st day of December 1963. Said lands are situated partly in Richland Township, Beaufort County and Township Number Three, Pamlico County, North Carolina and more particularly described as follows:

Beginning at a concrete monument marked with the letter "A" in the division line of Pamlico County and Beaufort County; said monument being North 84 degrees 10 minutes west 93 chains from an iron and concrete marker in the Southern line of the Gideon Williams Patent No. 213, and from this beginning point running North 25 1/4 degrees west 121 chains to a concrete monument; thence North 4 degrees East 13.8 chains to a concrete monument; thence North 86 degrees west approximately 88 chains to a concrete monument on the edge of a canal; thence South 1 1/4 degrees West 25 chains along said canal to a concrete monument; thence South 7 1/4 degrees East 110.65 chains to a concrete monument; thence South 1 1/4 degrees West 78.2 chains to an iron marker in the center of a canal; thence South 88 degrees 55 minutes East approximately 80 chains to an iron marker in the center of a canal; thence South 1 1/4 degrees West 160 chains to an iron marker in the intersection of two canals; thence South 88 degrees 55 minutes East 80 chains to an iron marker in the intersection of two canals; thence North 1 1/4 degrees East 120 chains along said canal centerline to an iron marker; thence South 88 degrees 55 minutes East 32 chains; thence North 57 degrees 55 minutes East 392.4 feet; thence North 1 1/4 degrees East 116.8 chains (crossing a canal at a distance of 37.3 chains); thence North 84 degrees 10 minutes West 78.6 chains to the point of beginning, containing 4463 acres.

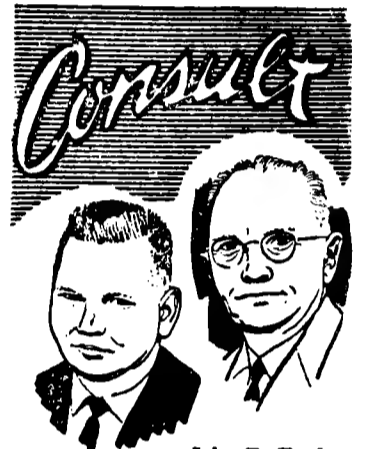
