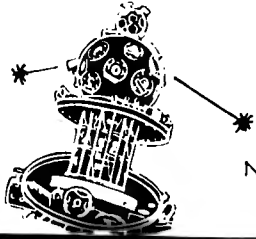
- ★ **MOON** Last quarter, 6th; new, 14th; first quarter, 22nd; full, 28th.
