Raised or reared as folks say now, in a Baltimore orphanage, he was as carefree as a robin on the wing. He delighted in pranks, often to the dismay of the New York Yankee front office.

Sometimes celebrities are disappointing when you meet then in the flesh. You could not say that about the Babe. He wore his fame as comfortably and as unassumingly as a baggy sweater.

Our first contact with the Sultan of Swat came as a youngster. He cheerfully signed our autograph book, but forgot to return the Parker fountain pen we had handed him to write his signature.

Because it was a good pen that cost us \$3.50, we hated to see anyone walk off with it, so in a timid, high pitched voice we asked for its return. Ruth gave it back, scooped us up in his big arms and roared with laughter.

The last time we saw him, years after his retirement, was at Yankee Stadium while we

It was a coolish October afternoon, and when the Babe arrived he was wearing his familiar tan topcoat and tan cap. A mounting hum of fan to fan comment surged through the crowd of better than 50,000 spectators, climaxed by an ovation as he took the final mincing steps to a box back of home plate.

The Sultan of Swat was destined to be in the House that Ruth built again, on a sadder day. Racked by an incurable disease that would shortly take his life, he would speak hoarsely into assembled microphones, and thank the fans and all America for their tribute to him.

Our only son, now grown, has a baseball we gave him, autographed by Ruth. What we couldn't give him were the personal memories we have of the greatest of them all.
