Last week, in a Senate Judiciary hearing on this issue, I urged the Committee to support S. J. Res. 28, a resolution which Senator Allen of Alabama and I introduced on January 23, 1973. The resolution, which would have to be approved by two-thirds of the House and Senate and ratified by three-fourths of the States. seeks to end busing to achieve "racial balance" and prevent Federal Courts and bureaucrats from practicing tyranny on helpless children.
