of impeaching a President of the United States is indeed a serious one. Therefore, I feel that the proper course of action for the United States House of Representatives to pursue at this time is to employ com-petent counsel, including of course the consideration of Archibald Cox, to make a thorough investigation; and if the charges of misconduct can be documented, then impeachment proceedings should begin at once."

Also during the week as the Mid-East War, which for a 24-hour period threatened to develop into a possible third World War; and at this moment, it appears that prompt and diplomatic action has prevented this.

Legislative action was at a minimum, but the House did approve the Emergency Medical Services Act of 1973. This is the bill that was approved by Congress during the month of July, and on August 2 President Nixon vetoed the bill, his objection being the forced continuation of eight Public Health Service Hospitals. The bill approved last week omits the forced continuation of hospitals, but this prohibition on the closing of the eight hospitals is now contained in the Defense Authorization Bill. The Emergency Medical Services Act is designed to provide medical care through ambulance services, emergency rooms and other facilities, and properly trained personnel. During the debate it was estimated that with prompt emergency treatment at least 60,000 lies could be saved annually. It is anticipated that President Nixon will not veto this legislation, for it does not contain his former objections.

Much concern has been expressed recently over a threatened shortage of fertilizer for the coming year. At the insistence of some of us, the Cost of Living Council last week lifted price ceilings and further ordered that several plants which had been closed must be reopened. This action is expected to alleviate the threatened shortage. This is the first time that the Council has lifted a ceiling on any commodity, indicating the seriousness of the situation.
