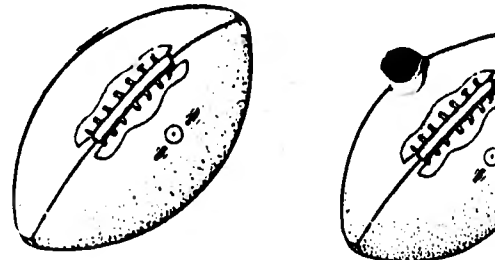

**RULES**

One game being played this weekend can be used for one entry. Pick the winner (not the score) and list it below. Do not make an entry blank. The three entries with the most correct entries will win first, second, and third place weekly prizes. \$5 for first place, \$2 for second place, and \$1 for third place.
