### Training Offered For Citizen Activists

As North Carolina faces an ever-increasing array of environmental issues--from hazardous waste facilities to peat mining--local citizens are becoming more vocal. An effort is now underway to help Tar Heels direct their energies more efficiently.

The Environmental Action Workshop, to be held May 3 in Fayetteviile, is designed to help concerned citizens who may not always know where to turn, who to talk to, or how to get help and information for dealing with iocal environmental controversies.

It will run from 9 a.m. to 4 p:m. at Methodist College, with a \$5 registration fee.

The Environmental Action Workshop is sponsored by the Conservation Council of North Carolina and the Durhambased Institute for Southern Studies. The program was developed by the Environmental Resources Project at the University of North Garolina-Chapel Hill.

Methodist College is the host, and the Pamlico-Tar River Foundation of Washington, N.C. and the Cape Fear River Research Institute of Fayetteville are cosponsors.

"If you don't know where you're going, you'll probably end up somewhere else," the workshop slogan says. The program is designed to help inexperienced activists get involved in conservation and public health issues in eastern and central N.C.

Director of the UNC Institute for Environmental Studies, will provide an overview of state government boards and agencies affecting the environment.

Participants will then break into small groups for hands-on case study sessions based on actual N.C. controversies involving radioactive waste, water pollution, land use planning, wetlands protection, and hazardous waste.

Action plans developed by the individual groups will then by compared and analyzed.

In the afternoon, participants will choose from among skill-building workshops in working with the media, legislators, administrative agencies, and scientific and technical experts. There will also be a session on conflict resolution.

Case study and skill workshop leaders include representatives of conservation organizations, govern-ment agencies, and universi-

The entire workshop will be oriented specifically toward average citizens. The idea for the program began at a meeting last fall of representatives of 30 N.C. environmental organizations.

Registration will begin at 8:30 a.m. May 3 in the Science Building at Methodist College. The college is on U.S. 401 north of Fayetteville (5400 Ramsey St.). Lunch will be availabe at the college.


