Superior Court convened Monday for the trial of criminal cases, with Judge Clayton Moore, of Williamston, N. C., presiding.

Shaheen and Leo Shaheen; State vs. Royal Daniel, Jr., alias capias and continued; State vs. Clyde Smith; State vs. William Warren; State vs. Odell Scott; State vs. George Livesay; State vs. Richard B. Miles; State vs. Will Talley; State vs. Ray Crawley; and State vs. Henry Gurkin. The case of E. A. Matthews was

also continued, but the Court ordered that when the defendant is apprehended his bond be set at \$5,000.

The defendant plead guilty and was sentenced to be confined in the common jail of Halifax County for twelve months, to be assigned to do public work under the direction of the State Highway and Public Works Commission of the State of North Carolina.

In the case of State vs. Dolphus Woodruff, which is an appeal from the Recorder's Court, the defendant plead nolo contendere upon charge of carrying a concealed weapon. Judgment of the Court was not entered.


