having burst forth in gorgeous glare this week.



## Many Owners Are Not Keeping Dogs In As Ordered By May

Dogs continue to run the streets of Roanoke Rapids despite the order by Mayor Jenkins issued last week that all owners pen their dogs up for thirty days.

Officers report killing a half dozen more dogs since those killed the first of last week. A half dozen persons bitten are taking the dreaded treatment.

Officer Green made the rounds of the town today and notified several dog owners to pen up their dogs. He says he found several owners who thought if their dogs had been inoculated for rabies the pen-up order did not refer to

He pointed out that the deg of Zollie Powell, killed last week, had been reported mad altho the dog had been inoculated. In short, the treatment is not 100 per cent sure cure and when the Mayor
