# **AUTOPSY**

Lewis Lynch, Hollister Negro, was released from the Halifax County jail yesterday cleared of charges brought by his deceased wife's relatives that he had killed his wife.

The wife was buried two weeks ago. Later her relatives claimed that Lynch had choked her to death and that she was buried before they had a chance to prefer charges.

The body was disinterred Tuesday of this week after an order for digging up the body had been obtained by the Coroner from Superior Court authorities.

An autopsy was held but no evidence of foul play was found and Lynch was released from jail where he had been placed when the order to disinter had been granted.
