Stricter enforcement of laws regarding sale of cigarettes to minors and the operation of bicycles in Roanoke Rapids after dark will be carried out by local police, according to an official announcement made yesterday by Police Chief H. E. Dobbins.

And Lights On Bicycles

Laws Re Smokes To Minors

Increase in complaints by parents and school authorities of sale to minors of smokes brings one warning of existing laws, while increase of the number of bicycles in the city since Christmas and recent automobile accidents brings the oth-

All persons selling smokes are warned that it is a violation of the State Law for any retailer to sell cigarettes, cigarette papers or substitutes to any child under 18-years of age, unless said child has a written order from their parents or guardian.


Any retailer who violates this law in the future will be prosecuted to the full extent of the law.

Parents wishing minor children to purchase cigarettes for them will please take notice and issue an order in writing for their purchase. Please do not blame the merchants if they refuse to sell a child cigarettes unless they have an order.

Regarding the bicycle situation, police point out it is a violation of the law for any person to operate a bicycle on any city street after dark without sufficient warning lights.

Anyone caught violating this law will be indicted. In the case of an adult there will be prosecution; in the case of a child, the bicycle will be confiscated.

These measures are being adopted in order to protect the youth of the city from harm and acciv dent.
