## SALES TAX **DEMANDED** BY STATE

Local Business Men Feel Sting Of Unfair Sales Tax Law

Agents of the N. C. Department of Revenue, under authorization of the past two or three the law as passed by the last session of the Legislature, have been in Roanoke Rapids for the other retail establishments in the city.

In cases where there


were no records kept, the agents have estimated what they think was the amount of business done and have rendered bills to the owners for back sales tax.

Local merchants have been charged with back taxes ranging from a few hundred dollars to nearly three thousand dollars, for sales tax which the State Revenue agents say are due for years.
