He is also reported to have holdings in other businesses in the city.

Mr. Smith of late years has been interested in the politics of the city, having served as Commissioner in 1935-36, ran for Mayor in 1937, and was a member of the Board of Commissioners at the time of his death, having been elected in May of this year.
