

7457 NAMES LISTED IN CITY; 2 MORE REPORTS TO COME

94.3% Of Census For 1930 Listed In Second District

6 census enumerators in Roanoke Rapids have turned in 7457 names for the city at this time, according to information received here today from the Second Congressional District. Two more enumerators from A. M. Atkinson, Census supervisor of the Second Congressional District within the city and have not yet turned in their lists of names.

An average of 1236 names have been turned in from the six completed districts here. The highest totaled 1739, while the lowest showed only 764. There is a possibility that the two enumerators who have yet to make their reports will have larger totals than any of those turned in, in that their work is requiring a greater length of time. Mr. Atkinson said that he believed that a complete report on the city would be available by the next issue of the paper.

The supervisor stated that his 35th daily report showed that 94.3 per cent of the population in 1930 had been enumerated at this time. The 1930 census showed the Second District had a population of 276,795. At the present 261,196 have been enumerated.

Total number of farms enumerated thus far is 23,433; houses, 57,107.

As soon as the remaining enumerators turn in the names from their districts within the city, Mr. Atkinson said that he would come to Roanoke Rapids and make a complete check up through the books in the city hall to determine whether all names had been turned in.

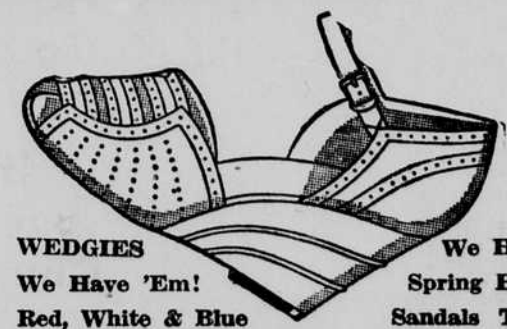
