




Joe Riddick, Sheriff of Halifax County, and George Pittman, deputy and county jailer, left Halifax early Tuesday morning for New York City where they will obtain custody of James Luter, local Negro man, charged with the fatal shooting of Susie Young, colored woman of the South Rosemary section, on the night of June 29. Luter was located, after a week's search, in New York City and was arrested by the New York police on instructions sent by the county officers.

Local officers solved the whereabouts of the wanted killer after several false leads had been tracked down here. It was through their continuing vigilance and untiring effort to run down every clue that they were able to send word to the New York police that Luter would be found in that city at a certain address.

The arrest was made Monday morning. Sheriff Riddick and Pittman left for the big city by car
