



## HELD ON SATURDAY

Director C. W. Davis of Volunteer Service and Public Information for the Committee on Civil Protection here announced today that registration of local men and women for civilian defense will take place here Saturday.

Tentative plans call for registration of all men and women who will volunteer their services, and they are asked to fill out the registration cards at any one of three places in the city-Boston Chain Store, 200 Roanoke Avenue; Municipal Building, Roanoke Avenue; or the old Rosemary Cafe Building, Roanoke Avenue in the Rosemary section of the city.

Any adult, man or woman, who might be able to assist the local committee at the registration places is asked to contact Director Davis, who stated today that teachers of the local schools will be asked to help citizens fill out the registration cards, along with volunteers for that service.

It is hoped that at least 2,000 adults here will register for civilian defense, and probably more than that number will patriotically volunteer their services in order that the city may be able to cope with any emergency arising in the near future.

Estimates of the number needed for various duties are as follows: 300 persons to assist Air Raid Warden A. E. Akers; 200 as helpers for Don Tillar, head of Emergency Utilities; 250 assistants for Virgil McDowell, heading Emergency Public Works; 200 to work with W. P. Taylor, Fire Prevention head; 150 persons to assist Chief of Police H. E. Dobbins, Police Head; and 125 to assist T. J. Alford, heading Medical and Health group.

REGISTRATION CARDS

The registration cards to be filled out by those volunteering for Civilian Defense will require the following information: name, date and place of birth, citizenship, race, home address and telephone, what hours of day available for
