## **DEFENSE WORKERS COMPLETE COURSE** IN CHAPEL

### **Civilian Corps** Here Will Get **Early Training**

Frank Sherry, Shearod Crumpler, Chief of Police H. E. Dobbins and Gene Lehman, all of Roanoke Rapids, returned to the city on Saturday after undergoing a week's training at Chapel Hill in the various phases of Civilian Defense work, a course sponsored by the Federal Bureau of Investigation.

The local men were given an insight into what the duties of the Civilian Defense Corps are expected to be in the event of an actual air attack on the cities and towns of this section. Included in the courses they studied were the duties of police, fire departments, air raid wardens, fire bombs, fire explosives, war gasses, gas decontamination, work of bomb squads, blackout regulations and many kindred subjects.

In charge of the school was Don S. Hostetter, special agent of the F.B.I., who studied courses in defense work under two special agents who spent three months of the past year in England under actual civilian defense service with the London corps, and who then attended a course in chemical warfare at Edgewood Arsenal at Edgewood, Md. The course was extensive and arranged for the purpose of giving all defense workers the benefit of actual experience gained in London and which could happen here.

The local men will select a group of volunteers from the Roanoke Rapids Civilian Defense corps and train them from the knowledge gained at the Chapel Hill course, and these volunteers will in turn pass the information aong to the several hundred workers who have registered for duty in the local corps.

The Roanoke Rapids men who represented the city at the course plan to consolidate the information they received at the course so that every worker registered with the local Civilian Defense corps will have a knowledge of the duties he or she is supposed to carry out during blackout and air raid tests and, if the time ever comes, during actual air raids.
