# **GOAL REACHED** . IN WAR DRIVE **OF RED CROSS**

### **Drive Goes Over Top** With \$11,246 Given To Local Chapter

The war fund drive of the local chapter of the American Red Cross has finally been attained, according to announcement made today by L. S. Neal, chairman of the annual roll call drive of the Roanoke Rapids chapter.

The goal for the local chapter was \$10,000.00, and this amount has been exceeded by \$1,246.47, according to figures made public by Mr. Neal today. Last week it was announced that the local chapter was several hundred dollars short of attaining their goal in the war fund drive, and an appeal for donations among city theatre-goers was resorted to in order to make up the deficit. The campaign in city movie houses not only made up the deficit, but enabled the chapter to exceed their quota by a substantial amount.

Allotments for each individual county are as follows: Edgecombe \$596,200.00, Chairman for the County, S. N. Clark, Tarboro; Halifax \$695,600.00, Chairman for the County, F. H. Gregory, Halifax; Nash, \$883,300.00, Chairman for the County, F. P. Spruill, Rocky Mount; Northampton, \$281,600.00, Chairman for the County, H. R. Harris, Seaboard; and Wilson, \$1,021,300.00, Chairman for the County, A. D. Shackelford, Wilson.

These allotments are for sales to individuals, corporations and other than banks and the North Carolina Banks are expected to buy for their own account about \$50,000,000.00 additional bonds, being a part of the \$8,000,000,000.00 to be sold in the United States during the month of April to other than banks and the sales to banks are set at \$5,000,000,000.00, making total bond sales \$13,000,000,000.00, being the largest sale of government securities that any government in the world has ever offered at one time.
