Constitution Of Student Government

CONSTITUTION OF THE STU-DENT GOVERNMENT ASSOCIATION

ARTICLE I

Name

The name of this organization shall be the Student Government Association of Queens College.

ARTICLE II

Purpose

The Student Government Association has set the following aims as the purpose of its existence: To encourage self-government; to promote constructive policies pertaining to scholastic and extra curricula activities; to stimulate the highest standards of honor in all matters of personal conduct; and to make and to enforce regulations which are in harmony with the College administration and which will encourage a progressive and a co-operative student life.

> ARTICLE III Membership

All students of Queens College are members of this organization upon fulfilling the following requirements:

- 1. Acceptance of the Honor System.
- 2. Attendance of handbook classes and the passing of an examination on the contents of the handbook.

ARTICLE IV Honor System

Section 1. Explanation of Honor System

It is agreed that the Honor System is one of the cherished possessions of the College and of fundamental importance in the building of that Christian character to which Queens College is dedicated.

The strength and effective operation of Student Government depends upon the loyalty and co-operation of each student. All of college life is based on the three fundamentals which constitute the Honor System.

 - (1) The Honor Council may, at its discretion, summon before it any member of the Student Government Association.
 - (2) The Honor Council shall, at its discretion, call in the Advisory Committee to its

(3) The Honor Council has the power to investigate and to take action in any case involving an infraction of the regulations of the Honor System that comes under its jurisdiction, and any student found guilty by this council, automatically excludes herself from the student body, or, in the case of extenuating circumstances, is suspended on the recommendation of the Honor Council to the Administration of the College.

 - (2) The Vice-President shall assume the duties of the President in the absence of this officer.
 - (3) The Vice-President shall serve as Chairman of the Legislature, but shall not have a vote except in case of a tie.
 - (4) The Vice-President shall be member ex-officio of all Legislative committees.
 - (5) The Vice-President may declare Legislature closed whenever it is deemed necessary for the efficient working of this body.
 - (6) The Vice-President shall direct Orientation Week.

c. Secretary

- (1) The Secretary of the Student Government Association shall be elected from the incoming Junior Class.
- (2) The Secretary shall keep a record of the proceedings of the Student Government Association and shall report the proceedings of Legislature if such is deemed advisable.
- (3) The Secretary shall publish all laws passed by the Association, shall attend to its correspondence, and shall give the notice of all elections and meetings of the Association.
- (4) The Secretary shall notify all members of the Orientation Committee of the date of Orientation Week and of their duties. She shall post all notices and attend to all correspondence of that week.
- (5) The Secretary shall be a member of Legislature and Secretary of that organization.

- (1) The Treasurer of the Student Government Association shall be elected from . the incoming Sophomore Class.
- (2) It shall be the duty of the Treasurer to have charge of the finances of the Association and to keep permanent records of all receipts and expenditures.
- (3) It shall be the duty of the Treasurer to formulate a budget for the coming year and to present this budget for adoption or rejection at the first regular meeting of the Association each year.
- (4) It shall be the duty of the Treasurer to present a report showing all receipts and expenditures of the Student Government Association at each regular meeting of Legislature.
