Attendance Responsibility for District Meetings

In compiling the schedule for district meetings each year extreme effort is exerted to avoid major conflicts, particularly with respect to stated communications of lodges. But with such a long state to cover, and with 65 individual district meetings to arrange, and with the unavoidable commitments of the Grand Master and the Grand Secretary, it is next to impossible to arrange a schedule absolutely devoid of conflicts.

It is therefore incumbent upon the District Deputy Grand Masters and the lodge Masters to work around conflicts where they do exist. If a lodge has a stated communication the same night of its district meeting, that stated communication can be presided over by a Past Master and the business transacted that night held to a minimum. Lodges should NEVER schedule degree work for the same night the

District Officers Meet Greenville and Hickorv

On consecutive Saturdays, April 30 and May 7, Grand Master J. Earl Watson and Grand Secretary Robert P. Dudley met with the officers of the 65 North Carolina Masonic Districts to outline work and objectives for the new Grand Lodge year. The first meeting was at Greenville with the DDGM's, DDGL's and DEC's of the eastern half of the state. The following Saturday was at Hickory with the district officers of the western half. Each meeting opened at 2 p.m. in the Masonic Temple. The Grand Master spoke to the entire group, then they divided into three classes; Grand Lecturer Gilbert English and Custodians Secretary Floyd Dunn met with the DDGL's Grand Steward Boyd Hopkins took the DEC's, and the Grand Secretary met with the DDGM's. The Grand Master met briefly with each of the separate groups
