Commission seats open next year

WILLIAMSTON - Those interested in becoming involved in politics have their opportunity.

Yesterday (Monday) at noon, filing opened for national, state and local offices for the 2020 election cycle.

In Martin County, three commissioners and the register of deeds will be up for election during 2020.

The three seats on the Martin County Board of Commissioners will be those held by the three Eastern District Commissioners - Democrats Tommy Bowen and Dempsey Bond and the board's only unaffiliated member, Elmo "Butch" Lilley. All three have served multiple terms on the county board.

Bond filed Monday.

Lilley is not required to file in December if he maintains his status as an unaffiliated candidate, as he will have to file via petition.

Kimberly J. Griffin is the current Martin County Register of Deeds, having been elected to her first full term four years ago.

Griffin filed for re-election Monday.

Nationally, 2020 is a presidential election year, meaning candidates for president will have to file. Republican President Donald J. Trump has announced his intention to seek another term. There is
