Threat at school unfounded

Controlled dismissal Friday at Riverside MS

WILLIAMSTON - Law enforcement and school officials are grateful a Friday afternoon scare ended safely at one middle school in Martin County.

"Friday afternoon, Riverside Middle School received

a threatening phone call," according to Superintendent Chris Mansfield. " School administrators moved the school into a soft lockdown situation while the veracity of the threat was being investi-

Together with law enforcement, school officials determined that a controlled dismissal could be safely conducted.

"I am appreciative of school and district staff for taking appropriate action. I am also appreciative of Williamston Police and Martin County Sheriff Department officers for their actions in the investigation

of the threat and in assisting with the safe school dismissal," Mansfield added.

Chief Deputy Drew Robinson of the Martin County Sheriffs Office said the threat was "ultimately unfounded;" however, the incident remains under investigation.
