Applications are accepted at the Martin County Department of Social Services, 305 East Main St., through Dec. 31.

As the year draws to a close, Dec. 27, 30 and 31 are the final opportunities to file applications.

Letecia Erby, Director of Martin County Social Services, explained applicants should bring their identification and the staff members will help them complete the process.

Households with a person age 60 or older or a disabled person receiving services through the North Carolina Division of Aging and Adult Services can apply through Dec. 31.
