

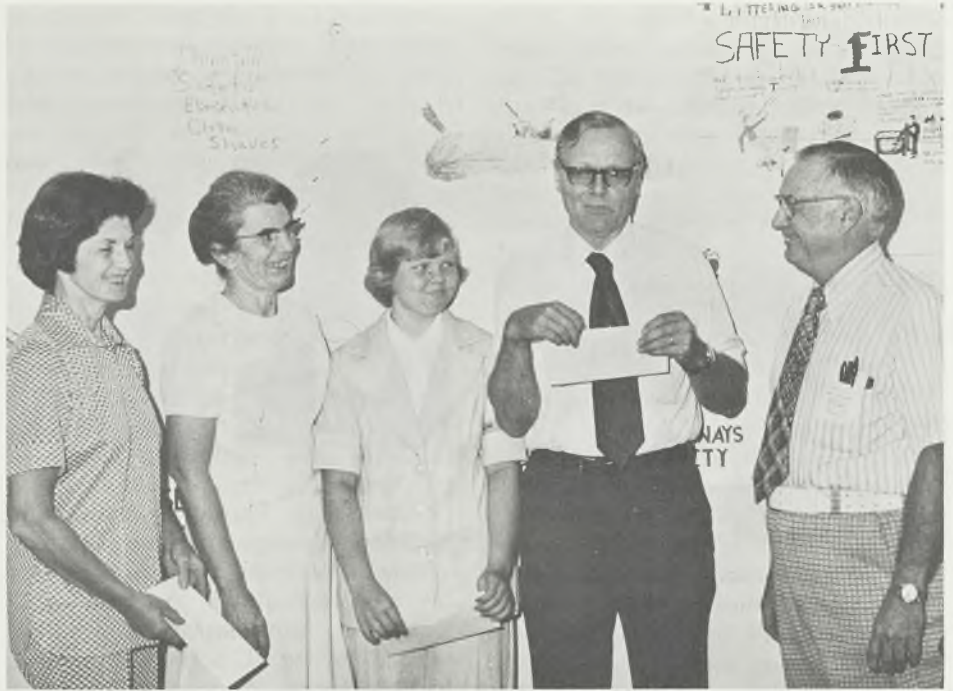
APPOINTMENTS (cont'd)
