The letter with which General Porfirio Diaz announced, on May 25, 1911, is resignation from the presidency of lexico after having been master of the ountry for 35 years gives in his own words an interesting glimpse of his remarkable career. It reads:

"Sir: The Mexican people who generously have covered me with honors, who proclaimed me as their leader during the international war, who patriotically assisted me in all works undertaken to develop industry and the commerce of the republic, establish its credit, gain for it the respect of he world and obtain for it an honorable position in the concert of nations -that some people, sir, have revolted in armed military bands, stating that my presence in the exercises of the supreme executive power is the cause of this insurrection.
