McCormick, of the Acme Manufacturing company, expects to leave tonight for Washington, where he will go to take up with Senator Simmons and the interstate commerce commis sion a request recently made for retention of the 10 per cent reduction in railroad rates for watermelon shippers of North Carolina, which expire under present arrangements on June

30th Mr. McCormick brought the matter to the attention of Senator Simmons sometime ago, pointing to the fact that melons do not begin to move from this state until after June 1 and therefore if the rates obtained by Florida and Georgia shippers are cancelled as of June 1 it will be discriminating against North Carolina growers




