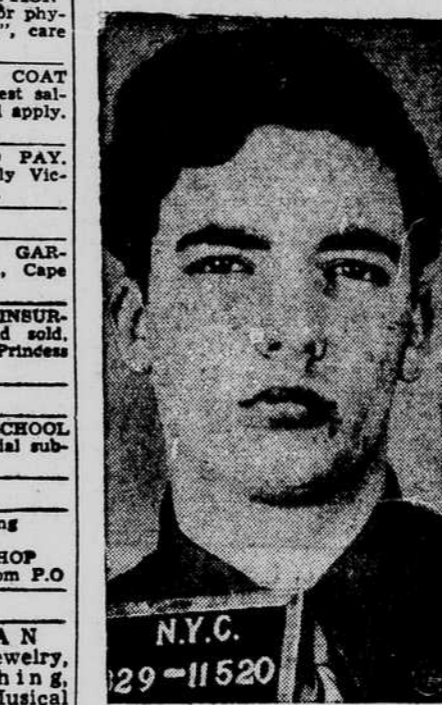

Man, Sought In Death Of Woman, Slays Self

PROVIDENCE, R. I., April 1.—A man sought since Friday night on a charge of murdering a Greenfield, Mass., woman, Harland Pratt, 28, medically discharged soldier, walked into the New Haven railroad police office today and shot himself to death.

Patrolman Frank Huntoon of the railroad police reported that Pratt appeared on the station platform and seemed to be highly nervous. Finally, Huntoon said, the man entered the police office, mumbled for a moment and then, drawing a .38 caliber revolver, shot himself in the stomach.
