



Not so many months ago the world was more or less confidently expecting peace. The most devastating of wars ever to afflict this planet was over. The nations of the world had united in an organization purportedly to keep the peace and to bring to the world the "Four Freedoms." Nazism was presumably stamped out. Our own nation had experienced of unusual unity of purpose and effort stimulated by the pressure of war.

Today the world seems to be in as sorry a plight as ever. War goes on in China. Civil conflict rages in Eastern Europe and in the land which gave birth to the Prince of Peace.
