

OPPONENTS SAY RESOLUTION TO CAUSE TRAGEDY UNC Trustees Vote To Admit Negroes After Stormy Raleigh Meet

RALEIGH - A resolution which one oponent declares will "cause Hoodshed in North Carolina" went onto the records here Wednesday when the Board of Trustees of the Greater University of North Caroling voted that qualified Negro students may be admitted to professional and graduate schools of the state-owned and operated institution.

By a 61 to 15 vote and following exhausting arguments in which op-ponents of the measure called down the wrath of God upon those seeking to "mongrelize" the white race, the trustees decided that "in al leases of applications for admission by members of racial groups, other than the white race, to the professional or graduate schools when such schools are not provided by and in the State of North Carolina for such racial groups, the applications shall be processed without regard to color or race."

North Carolina Korea War Vet Given Citation

FORT BRAGG - Master Sergeant David Robinson, native North Carolinian and veteran of nine years service was presented the Silver Star, during an appropriate ceremony at the U.S. Army Hospital here last Fridiay. The medal, one of the highest given military personnel by the government was presented and appropriately pinned on Sergeant Robinson by Colonel Charles B. Kendall, commanding oflicer of the hospital.

The citation revealing Ser geant Robinson's bravery and devotion to duty while engaged in combat against the armed enemy in Korea and which entitled him to the Silver Star read: "On July 21, 1959, near Sanju, Korea, Master Sergeant David Robinson, while going from a forward platoon under heavy fire to call for artillery fire, recovered two wounded men from an exposed position and removed them to safety.

Despite heavy hostile action, he also saved two trailer loads o vital equipment. On July 29 he again saved four men who were being evacuated on a tank which had come under severe fire. Later that day he commanded the company for four hours and held a critical hill which the enemy was endeavoring to take. On August 31 when the enemy broke through and cut off his platoon, he kept his men in place and inspired them to hold and tight off repeated fanatical altacks for two days until relief





