Order Ousting Negro Candidate In Raleigh Elections Reversed

BOARD RESCINDS LAW

RALEIGH — A situation which lasted some 24 hours and during that period was termed everything from "deplorable" to "dictatorial" was reversed here this week when the lone Negro candidate for public office in the municipal polling had a valiant fight for "The People".

In unprecedented action on Tuesday, the Wake County Board of Elections, under whose jurisdiction Raleigh elections are held, declared active a local statute provision which would have ousted a Negro candidate and four white candidates for City Council seats from the race.

TAYLOR STILL TO RUN

In action equally as unprecedented, the same Board voted Wednesday to rescind its action and to govern the current race for seven seats on the local City Council in accordance with past policy.

On Tuesday, the Elections group had declared that a provision stating that the six top men in the

Dr. Bunche To Address A & T College Finals

GREENSBORO, N. C. — Dr. Ralph J. Bunche, winner of the 1946 Nobel Peace Prize, will deliver the Commencement address at A and T College, at 4 p.m. Monday, May 28, in the Richardson B. Harrison Auditorium.

Dr. Bunche, internationally famous for his successful mediation of the Palestine dispute two years ago, is one of the nation's foremost authorities on governmental and international affairs. He began his work with the Federal Government in 1941 as Senior Social Science Analyst for the Federal Coordinator of Information.

He was appointed a Director of the Division of Trusteeship for the United Nations in 1946, and moved to the top-ranking director, the position he now holds, in 1947.

He was made Acting United Nations Mediator on Palestine in September, 1948, and held the position until August, 1949.

Dr. Bunche received his Bachelor's degree from the University of California, and his Master's and Doctorate degree from Harvard University. His post-doctoral work was done at North Western University, the London School of Economics, and the University of Capetown, South Africa.

In addition he has received

22 honorary degrees and innumerable awards.

Other activities of the A and T Commencement will include the Commencement sermon at 11 a.m. Sunday, May 27, in the Harrison Auditorium, Dr. Charles W. Gilkey, Dean, Episcopal Chapel, University of Chicago, will deliver the sermon.

BEAUTY SCHOOL FRAUD TRIALS SET NEXT WEEK

WINSTON-SALEM — The mass trial of a local beauty school head and 74 GI students on a series of fraud charges is scheduled for next week in Federal Court here.

The defendants were seized last month in a roundup which was touched off by an investigation of the enrollment records of the Larklee Beauty College, 602 Patterson Ave.

Free in bail, all are charged with defrauding the Veterans Administration under the educational provision of the GI Bill of Rights.

The first arrested was Mrs. Ola Foote Bell, owner and president of the school, who was taken into custody by Federal agents on April 17. She had been indicted on 9 counts by a Federal grand jury in Salisbury the day before.

The indictment charges Mrs. Bell with submitting false claims and vouchers to the VA. It is also charged that she and the college made false entries of attendance.

It Happened In Carolina

Put Him Away

HIGH POINT — The only thing to do with a man like you is to put you away—I hope they can keep you.

The above statement was made by Guilford County Superior Court Judge Dan K. Moore immediately before the jurist proceeded to "put away" an escapee for a long period of time.

The court ruled that Garland McGeigior, who on April 22 escaped from the Guilford County House at Greensboro, heard himself sentenced to 25 to 28 years in prison on charges of breaking, entering, larceny and receiving. McGeigior also has appointments before other judges to hear trials on other charges, including six at Thomasville for breaking and entering.

Woman Paroled

RALEIGH — A woman who has served four years of a 15 to 20 year sentence for second degree murder was among persons granted paroles here this week.

Miss Anne Wadd, who was sentenced from Guilford County in April, 1947 received the clemency.

Being Sought

EDENTON — Jimmie Lee Holmes is being sought in the area this week in connection with the fatal shooting of Mrs. Viola Holmes, 28, and the injury of Celia Mebane, 27. Local officials report that the Mebane woman revealed that the Holmes were engaged in an argument in her presence at the Holmes' home when the husband suddenly grabbed a shotgun and fired, killing the wife and inflicting injuries upon her person. The man fled following the shooting.

2 Die In Mishap

FAYETTEVILLE — Two persons were instantly killed on a highway near here Saturday night and two others injured when an automobile failed to negotiate a curve.

Dead in the mishap which occurred near Parkton are Eugene Anderson, 24, and William Walker, 19. They died when the car driven by Anderson ran off the roadway and into a ditch after failing to make a turn.
