Release Of 4 Denied By A Judge

AMERICUS, Ga.— A Superior Court Judge here last week de-nied a defense attorney's motion for release of three civil rights workers facing charges which carry the death penalty.

Judge T. O. Marshall turned down a writ of habeus corpus filed by Albany attorney C. B. King on behalf of Student Nonviolent Coordinating Committee field workers Don Harris, a Negro, Ralph Allen and John Perdew, both white. They are held without bond on state charges of "attempt-






