HARDING HIGHWAY TO BE THE HIGHEST IN AMERICA

At Golden, Colorado, twelve miles west of Denver, the Harding Memorial highway, joint effort of the city, county state and federal government begins.

The first section which includes the famous Inland Trail over Mount Lookout was built by the city and county of Denver in the development of the Denver mountain parks. The second section, extending from Bergen Park to Squaw Pass was constructed by the United States Forestry Service.

At Squaw Pass four miles below Echo Lake the state of Colorado took over the work. Though the road will reach the summit of Mt. Evans this season, at least three more years will be required for its completion, as it is to be joined to the system of highways on the opposite side of the mountain.

The Harding highway in addition to its scenic beauty will be the highest automobile road in America, if not in the world. The price has fluctuated from thirty to ten thousand dollars a mile, according to difficulties encountered.

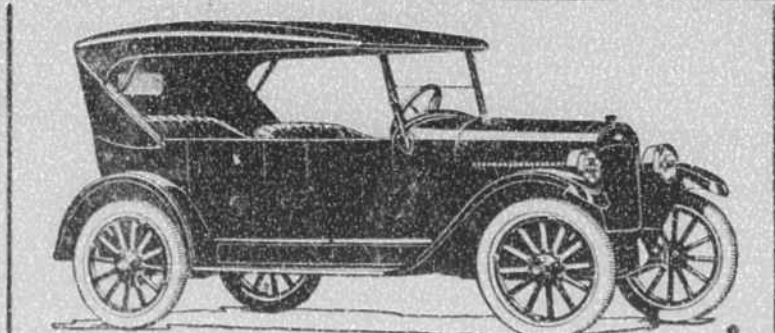
