It started last week in Thomasville on the 18th-19th at the Piedmont Festival. November 22, she will be in Kannapolis. Wednesday the 23rd, she drives to Charlotte for an appearance on Noon Report at 12:00 P. M. with Ty Boyd, then rushes back to Salisbury for their parade, then back to the Coliseum in Charlotte for a night appearance.
