

Rev. W. L. Freeman Speaker At Rotary Local Minister Discusses World Council of Churches

Edenton Rotarians at their meeting last week listened to a very interesting and informative treatise on the World Council of Churches, which was presented by the Rev. W. L. Freeman, pastor of the Methodist Church. Mr. Freeman referred to the assembly held in Amsterdam, Holland, as the greatest event since the Reformation in the way of church unity. He pointed out that underlying principles of the various denominations are one and the same, but that only pithy differences separate them.

"The world assembly," said Mr. Freeman, "opened the way to continuous cooperation between religious bodies through its creation of the Council".
