Godfrey, said today "as much as I hate to, I am forced to admit that some farmers in North Carolina penalize themselves hundreds of dollars each year on their cotton alone by dumping it on a crowded market." Godfrey pointed to the difficult task most Tar Heel farmers had raising cotton this summer. It has not been a good cotton year in North Car-olina. Yet, he said, a great many North Carolina farmers sell their cotton at sacrifice prices rather than have it graded and sell according to C., its true worth.
