Second Dose Of olio Vaccination **Given Last Week**

Children Treated Each Monday Afternoon In Edenton

The second dose of polio vaccina. tion was started in Edenton Monday of last week and according to Dr. B. B. McGuire, District Health Officer, 26 children were inocu lated.

Camden started Thursday of las week when only two children were treated. In Elizabeth City the program started Friday when 52 chil dren were inoculated. Dr. McGuire points out that only those children in the first and second grades the past school year are eligible to be vaccinated.

Vaccinations will be given until schools open in Edenton each Monday from 1:30 to 3 P. M.

"Parents should use their own judgment about taking the vaccine on the above days," says Dr. Mc-Guire. "but parents should accom pany their children or send a note requesting that it be given."


