

## **EXAMINE YOUR LIST BEFORE SIGNING**

### Report Your 1957 Crop Acreage Through Tax Lister During January, 1957

Your local Tax Lister is required to make the records but Farm Owners or Tenants must furnish the facts. Therefore, call your List Taker's attention to these records and be prepared to furnish the following information: (1) Acreage for each crop harvested during calendar year 1957. (2) Number of cows, sows, and hens on farm January, 1958. (3) Number of people living on farm January, 1958. All of the above information furnished will be considered as confidential and will not be used in any manner that is detrimental to the farmers concerned. It is not used for tax purposes.

## HAVE YOUR FARM REPORT READY FOR YOUR TAX LISTER

After February 2nd A 10% Penalty Will Be Imposed For Failure To List First Township Listing At Court House
